Dr. David H. Kupferberg is a triple board-certified Pulmonary and Critical Care physician with more than 25 years of active clinical practice spanning high-acuity ICU environments, consultative pulmonary medicine, Long-Term Acute Care Hospitals (LTACH), and Tele-ICU remote monitoring. He holds active medical licenses in more than 25 states and is available to provide expert review, written opinions, and deposition and trial testimony in cases involving pulmonary disease, critical care, and hospital standard of care.

Dr. Kupferberg's clinical background is unusually broad: he has managed critically ill patients at bedside in major academic medical centers and community hospitals, served as attending intensivist in LTACH facilities, and functioned as a Tele-ICU physician providing real-time remote clinical decision support. This breadth gives him direct, contemporaneous familiarity with standard-of-care obligations across multiple care settings. His Master of Public Health in Epidemiology and Biostatistics further equips him to analyze causation, evaluate medical literature, and address damages in an evidence-based manner.
